Alongside this, the team here was also pleased to secure funding for three new protected areas, mobilize real protection for the High Seas, call for Boreal forest protections and support nature restoration right at the local level in Bird Friendly Cities too!

PROTECTING SPACES AND SPECIES

Earlier this year, we celebrated some good news on the High Seas! With the tremendous help from all our members and supporters, Nature Canada, along with our partners, pushed our leaders to sign the United Nations High Seas Treaty. This treaty is a deep commitment to protect and conserve nature – specifically our oceans.

The ocean covers seventy percent of our planet and most of that area is international waters — the "High Seas". These areas are often treated as "open" for unregulated exploitation, leading to significant biodiversity loss. With Canada signing on, this treaty aims to reverse this decline by protecting biodiversity across nearly one-third of the global ocean. Ensuring a healthier, more sustainable future for people and marine wildlife, like sharks and whales that migrate far distances. This victory demonstrates that your voices can create a remarkable impact.

Every year, our team pushes to secure more government funding for new protected areas through the Green Budget campaign – and this year we got some big wins! Funding was secured for three hugely important new national protected areas, each integrally linked to the local Indigenous peoples:

The Central Coast National Marine
Conservation Area Reserve in British Columbia

which is an amazing marine area with coral and sponge reefs, eelgrass beds and kelp forests which support the abundant marine life found there;

- The Ojibway National Urban Park which will protect some of the last remnants of the original tallgrass prairie and oak savannah ecosystem near Windsor, Ontario; and
- The coastal dunes, old growth forest, and unique rock geology of Pituamkek National Park Reserve in Prince Edward Island.

We celebrate these wins which will add to the 15 percent of lands and waters that Canada has conserved to date. But as you know, we must **double our efforts** to achieve the promise of protecting 30 percent of lands and waters by 2030!

With the help of our partners, Nature Canada has prioritized protecting other Canadian spaces and species such as the Right Whales and Semipalmated Sandpipers of the Inner Bay of Fundy, our beloved Atlantic Puffins that rely on the waters around Witless Bay off the coast of Newfoundland, and the Pacific Loons and Orcas found in the busy Southern Strait of Georgia near Vancouver Island.

With you by our side, Nature Canada seeks to secure greater protections for these key marine areas this coming year.

ENVIRONMENTAL POLICIES & LAWS **UPDATE**

Thanks to supporters like you, Nature Canada intervened at the Supreme Court of Canada to stand up for the Impact Assessment Act, a critical tool for government to protect nature from harmful industries and development. Although the court ruled against our position, we're heartened the Court found that the Act still applies in cases where proposed projects like mines, pipelines and dams should be assessed to ensure no potential impact on fisheries or species at risk. More recently, we've started efforts to advance and socialize the Rights of Nature (which strives to give "personhood" to rivers, forests etc.) seeing this as a novel and game-changing legal tool to protect biodiversity in the future. COUNTING ON THE BOREAL FOREST AND TWO BILLION TREES TO COUNTER CLIMATE CHANGE

In January, Nature Canada along with other national experts released *The State of the Forest in Canada: Seeing Through the Spin*, which looked deeply into how forests in Canada are faring and challenged the government's positive view on the sustainability of the Canadian forestry sector. The scientific evidence clearly points towards the actual precarious state of our Boreal Forest. With devastating forest fires for a second year in a row, there is an even more urgent need to rally Canadians around stopping industrial clearcutting and addressing the climate impacts of the logging industry.

We must urge the federal government to be transparent and accountable and acknowledge the negative cumulative impacts of logging, rates of forest degradation, and carbon emissions caused by industrial logging (as the 3rd highest emitter!).



COLLABORATING TOGETHER

This year, tens of thousands of members and supportive Canadians were mobilized to make their voices heard through letters of hope with calls for action to secure a National Biodiversity Action Plan to halt and reverse nature loss. To complement this, 39 nature organizations from across Canada came together to hold 50 meetings with members of Parliament and ministers during our Nature on the Hill event to push for a plan of action. To all of our success, the Nature Accountability Act was finally released in tandem with Canada's 2030 Nature Strategy this past June to halt and reverse biodiversity loss in Canada Thanks to all for this incredible WIN for nature!

As well, our policy experts and partners repeatedly brought forth our concerns this past year about weaknesses and delays in the Two Billion Trees program and stressed the need to guarantee permanence for the trees being planted, if it is truly about carbon capture and countering climate change impacts. Our thanks to our members who stand beside us calling for strong nature-based protections in the face of the increasing impacts of climate change.

DEFENDBIRDS AT RISK

Nature Canada's unique national certification designates cities as "Bird-Friendly". This initiative thrives thanks to our passionate volunteer Bird teams, who engage in essential conservation efforts: they plant trees and pollinator gardens to provide nourishment and shelter for birds, and educate fellow community members on how to protect these beautiful creatures in their own backvards. Our dedicated teams install nest boxes and monitor and study birds, ensuring the ongoing health and safety of Canada's feathered neighbours. This work not only restores our natural urban habitats but also strengthens our resilience against climate change.

ENGAGE WITH NEARBY NATURE






Nature Canada financials for year ending in March 31, 2024
